

## HERTFORDSHIRE COUNTY COUNCIL

### **THE HERTFORDSHIRE (TEMPORARY CLOSING AND TEMPORARY WAITING RESTRICTIONS IN MANGROVE LANE, BRICKENDON AND GOOSE GREEN LORD STREET, HODDESDON) ORDER 2022**

NOTICE is given that Hertfordshire County Council intends to make an Order under Section 14(1) of the Road Traffic Regulation Act 1984, to prohibit all vehicular traffic from using the following lengths of roads ("the Roads"), except for access and to prohibit all vehicles from waiting at any time on both sides of these lengths of Roads whilst works are in progress:-

1. that length of Mangrove Lane, Brickendon from its junction with Monks Green Lane south eastwards, north eastwards, south eastwards and eastwards to its junction with Goose Green Lord Street, a distance of approximately 1127m.

An alternative route will be via Mangrove Lane. Mangrove Road, A414 London Road, B1197 (London Road/Hertford Road), A1170 Amwell Street, Amwell Street, Pauls Lane, Taverners Way and Lord Street.

2. that length of Goose Green Lord Street, Hoddesdon from its junction with Mangrove Lane north eastwards to its junction with Lord Street, a distance of approximately 553m.

An alternative route will be via Mangrove Lane. Mangrove Road, A414 London Road, B1197 (London Road/Hertford Road), A1170 Amwell Street, Amwell Street, Pauls Lane, Taverners Way and Lord Street.

The Order is needed because works are proposed to be executed on or near the Roads.

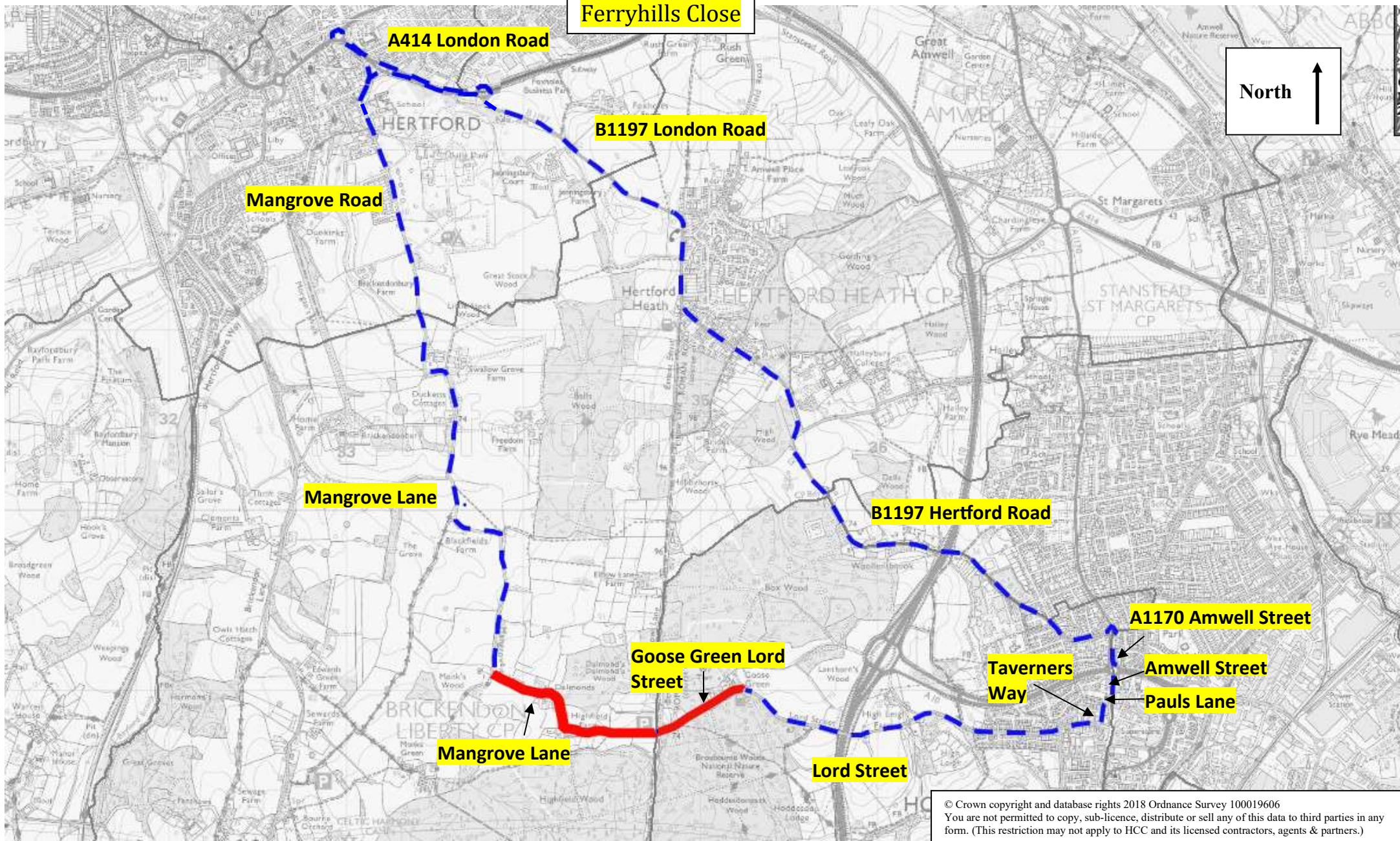
If the Order is made, it shall come into force on 31 January 2022 for a period of up to 18 months. However, the restrictions specified shall only take effect at the times indicated by signs on or near the Roads.

A copy of the proposed Order may be inspected free of charge at County Hall, Hertford between the hours of 9.00am and 5.00pm (excluding weekends, bank and public holidays).
